## **Board Chairperson and Executive Director Bret Schapman and Kathy Dickens**



*Four County Community Foundation initiatives are at work making a difference where we live. At the same time, significant grants are being made to non-profits, civic organizations, and schools so they can engage in solving these and other needs in ways they have identified.*

René Descartes, a well-known western philosopher, once proclaimed: "Divide each difficulty into as many parts as is feasible and necessary to resolve it." This ancient guidance is certainly applicable to the very large issues that impact the world today.

During COVID, Four County Community Foundation could not resolve food insecurity for our neighbors. We did organize drive-through food distributions in a partnership with the USDA.

We cannot solve the affordable housing shortage in our communities. We are building one nice 3 bed - 2 bath home in Imlay City in partnership with MSHDA.

We cannot solve the mental health crisis that seems to be growing among our youth. Our 4CCF Youth Advisory Committee is partnering with the Blue Cross Blue Shield Foundation and Skyline Camp to offer Teen Mental Health First Aid workshops to our local youth.

We can't solve all early literacy gaps created by economics, COVID, or other environmental factors. We can support our 4CCF Imagination Library Fund and put books in the hands of youth from birth to age five throughout the communities we serve.

We cannot solve a transportation shortage for senior citizens, but 4CCF did partner with Michigan Health Endowment to build a community coalition of leaders to study the problem, break it down into smaller parts, and address each one in turn. With a grant from the USDA, this coalition will now have two vans in Imlay City specifically for seniors.

We cannot prevent losing our best and brightest to careers in other areas of the country or world after graduating college. We can provide the 4CCF Return to Earn Internship to encourage our youth to return and explore their career field in our own community, with hopes they consider staying.

Four County Community Foundation does not look at very large problems and feel hopeless to make a difference. We have truly embraced the philosophy of Descartes: work together to make slow and steady progress on smaller parts of very big problems.
