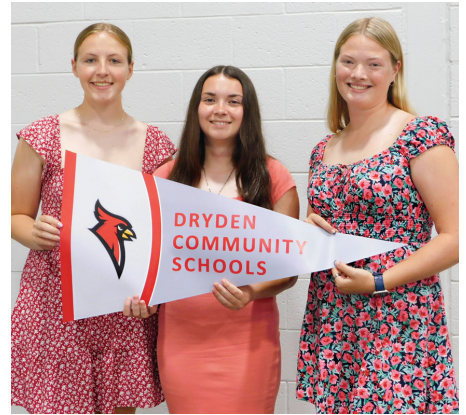

Academies at Romeo Community Schools Fund

The Academies at Romeo Community Schools Fund seeks to provide support for community-connected learning experiences for grades K-12 that align with the Academies at Romeo Community Schools model and mission.

Memphis Community Schools Education Fund

The Memphis Community Schools Education Fund will support innovative and enriching educational experiences for students across the Memphis Community Schools district. Donations to this fund will provide ongoing support for the competitive quarterly grant cycles administered by the Foundation. These grants will fund classroom projects, field trips, student clubs, and other initiatives that enhance learning, foster creativity, and build community within the schools and other “school sponsored” initiatives. Similar to other district-wide education funds held, the Foundation will be the fund representative for this new fund.

Donald Koning Scholarship Fund

The primary purpose of the Donald Koning Scholarship Fund will be to provide scholarships to graduating seniors and recent graduates of Capac High School who are entering the trades.

The Pond Guy Scholarship Fund

The Pond Guy Scholarship Fund intends to provide scholarships to high school seniors, college students, or up to two years post high school graduates, who are employed by, or have a parent or grandparent employed by The Pond Guy. This scholarship will also be open to Armada High School seniors pursuing a 2-year or 4-year degree, a trade, a certification, or any further education.
